Notice is hereby given that Voltalia UK Ltd company registration number 07489990, with its Registered Office at The Wheelhouse, Bond's Mill Estate, Stonehouse, Gloucestershire, England, GL10 3RF, has applied to the Scottish Ministers for consent under Section 36 of the Electricity Act 1989 to construct and operate a wind farm and battery energy storage system known as Cruach Clenamacrie, near Oban, Argyll and Bute (Central Grid Reference E194142 N729887). The installed capacity of the proposed generating station would be over 50MW comprising up to six turbines with a maximum ground to blade tip height of 200 metres and has been subject to Environmental Impact Assessment (EIA). An EIA Report has been produced to accompany the application for consent.

Voltalia UK Ltd has also applied for a direction under Section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.

Voltalia UK Ltd have now submitted Further Environmental Information (FEI) to the Scottish Ministers which includes revisions to the internal access track layout, information in response to the Scottish Environment Protection Agency consultation, an update to the cumulative Noise, Heritage and Landscape and Visual assessments and further clarifications relating to the Proposed Development.

Following examination of the environmental information, Scottish Ministers will determine the application for consent in one of two ways:

- Consent the proposal with or without conditions attached; or
- Reject the proposal.
